Personalized College Financing Plans must be provided within 15 days after tuition and fees are determined for the academic year if there is a change. Students may access their College Financing Plan through their CobraStop Financial Aid account.

Student Accounts, [student\\_accounts@coker.edu](mailto:student_accounts@coker.edu), will provide students with a Statement of Account that details tuition, fees, and other billing items.

The university informs an enrolled student of the availability of federal financial aid, not administered by VA that is offered by the institution. Students are provided an online offer document listing all available institutional, federal, and state financial aid. Students have the right to deny or reduce offered Direct Loan Subsidized and Unsubsidized Loans.

Students are notified of potential eligibility for other federal financial aid before packaging or arranging student loans or alternative financing. Students are provided an online offer document listing all available institutional, federal, and state financial aid.

Prohibit automatic renewal of a covered student in a course and/or program(s).

Ensure each covered student approves of the enrollment in a course.

Allowed enrolled members of the Armed Forces, including reserve and National Guard to be readmitted if such members are temporarily unavailable or must suspend enrollment by reason of serving in the Armed Forces.

Accommodate short absences for such services in the Armed Forces.

Schools must provide covered students the requirements for graduation and a graduation timeline. The Office of Academic Records notifies students of their eligibility for graduation and provides details for submitting graduation applications. Accredited educational institutions agree to obtain approval of the respective accrediting agency for each new course or program.

## **Section 2 – Point of Contact**

*The State Approving Agency will take action when the education institution does any of the following items.*

Carries out deceptive or persistent recruiting techniques including on military institutions.

Misrepresents payment of incentive compensation.

During a 1-month period makes three or more unsolicited contacts to a covered student via phone, email and/or in person.

Engages in same day recruitment and registration.

Provides a commission, bonus, or other incentive payment based directly or indirectly on success in securing enrollments or financial aid to any persons or entities engaged in any student recruiting or admission activities, or in making decisions regarding the award of student financial assistance. (Please note: Coker University already subscribes to this requirement under 38 U.S.C. subsection 3696(d)(1)).

## **Tuition Assistance**

Active-Duty military personnel, as well as reserve military, receive tuition assistance through various programs. Students who are eligible for benefits can obtain forms or website directions from their military educational liaison. The Federal Tuition Assistance website is [www.armyignited.army.mil/student/account/login](http://www.armyignited.army.mil/student/account/login). Students will turn in certified documents to the OFA veteran representative in order for the benefit to be certified. For most students this

form will be a Notice of Basic Eligibility (NOBE). The Office of Financial Aid (OFA) veteran representative will notify the Office of Academic Records and Office of Student Accounts (OSA)—the OSA will invoice the appropriate entity for payment. Students have to apply for the Tuition Assistance benefit prior to enrolling into courses to obtain approval.

Top-Up eligible students may use their Montgomery or Post 9/11 G.I. Bill benefit with Tuition Assistance funds, but VA will pay for a portion of tuition not covered by Tuition Assistance. Between the Montgomery or Post 9/11 benefit and Tuition Assistance, no more than 100% of the tuition will be paid.

Any Tuition Assistance received and in combination with received Montgomery or Post 9/11 G.I. Bill benefit in excess of 100% will be returned to either of the funding agency. If the student permanently withdrawals, takes a leave of absence, or withdraws/drops the approved Tuition Assistance course(s) up through the 60% of the enrollment period, then those funds will be returned to the funding agency. The percentage will be calculated based on the last day of attendance. If the student stops attending due to military service obligations, then student accounts will work with the student to not have a debt based upon the returned amount of Tuition Assistance.
